**PROCEEDINGS OF THE PUBLIC HEARING MEETING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT OF M/s. K. K. PELLETS PRIVATE LIMITED FOR ESTABLISHMENT OF 0.60 MILLION TONNES PER ANNUM IRON ORE PELLET PLANT AT VILLAGE SALARAPENTH OF GRAM PANCHAYAT- MAHADEIJODA, TEHSIL - SADAR IN KEONJHAR DISTRICT HELD ON 24.02.2015 (11.00 AM) AT SALARAPENTH VILLAGE IN KEONJHAR DISTRICT, ODISHA**

The Public Hearing meeting in respect of Environmental Impact Assessment of M/s. K. K. Pellets Private Limited for establishment of Iron Ore Pellet Plant having capacity of 0.6 Million Tonnes Per Annum at village Salarapenth of Mahadeijoda Gram Panchayat under Keonjhar Sadar Tehsil in Keonjhar district was held at the scheduled venue & time i.e. on 24.02.2015 (11.00 AM) at Salarapenth village in Keonjhar district, Odisha with reference to:

1. EIA Notification S. O. 1533(E) dated 14.09.2006.
2. Interim Operational Guidelines.

At the outset, welcoming the members participated in the meeting presided over by the Project Director, District Rural Development Agency, Keonjhar, the Regional Officer, State Pollution Control Board, Keonjhar, Odisha as well as the Representatives of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by M/s. K. K. Pellets Private Limited.

Welcoming the public, Dr. Giri, the Regional Officer, State Pollution Control Board, Keonjhar, Odisha explained the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Sri Subrat Kumar Mallick, addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other CSR activities envisaged in the proposed project.

Then Dr. Giri, Regional Officer, State Pollution Control Board, Keonjhar requested the public to give their views, comments, objections and opinions on the proposed project.

The following speakers gave their views on the above said project, which is given as follows:

**1. Sri Mangala Penthei, Salarapenth**

He informed the public that, it is very painful to tell that after selling of their land and they are without any work. The upcoming company shall give pension to old man and women, and give engagement to the unemployed peoples. Earlier 5 to 6 crushers had taken their land and are now closed and they have been left with no work and food. If the new plant operates the company shall give employment and provide a wage of Rs. 10,000/- per month to the people and can operate their plant. He welcomed the project.

**2. Sri Shyam Sundar Penthei, Salarapenth**

He informed that, they have sold their land and now do not have any work. He informed that earlier some company had taken their land and after engaging for some time period their jobs are terminated and the new upcoming company should not do so. The new company shall provide job to the land looser and they shall work sincerely for the company. He welcomed the project.

**3. Sri Sambhu Penthei, Salarapenth**

The new company shall try to repair and renovate their village roads. Pension shall be given to old people who cannot work and the people who are eligible for job shall be employed in the new proposed plant. A wage of Rs. 10,000/- per month shall be given to the employed people and the company can run their plant. He welcomed the project.

**4. Sri Padu Munda, Salarapenth**

The mine and crushers in their area are closed since long and people are without food and not getting any work. People are going to other places like Keonjhar, Raisuan and other far off places for work. The new plant should operate and run successfully.

**5. Sri Sudarsan Penthei, Salarapenth**

He informed that a plant is coming in their village Salarapenth and they have already given land for the plant and they want that the industry should come up. They have 18 numbers of demands which they want and those to be fulfilled. He also informed that is these demands are not fulfilled by the company then they will take the help of the law and lock the industry. They will discuss the matter with the management and also take the help of the law. If the new plant operates people will get job and be benefitted. He also intimated that, the company management had come to them and informed that they are going to set up a plant in their area and in due course of time will provide facilities like employment, drinking water, medical facility and road infrastructure. They village people wants the plants to come up and they will also cooperate with the company and also informed that the company should equally respond to their demands.

**6. Sri Mohan Penthei, Salarapenth**

He informed that the new industry should come up and provide job to the people so that they will be benefitted.

**7. Sri Ghasi Penthei, Salarapenth**

He informed that a plant will be set up in their village and the company shall provide facilities for their village Salarapenth like electricity, a common water pond for bathing purpose and a medical hospital and then the company can run the plant. He welcomed the project.

**8. Sri Dama Penthei, Salarapenth**

He informed that an industry like BRM Steel had been set up and closed for which they have already been affected and do not want the same thing to happen. He informed that the new plant shall provided employment to them and give a wage of Rs. 10,000/- per month and also pension to the old people and can run the plant.

**9. Smt. Jasoda Mohanta, Salarapenth**

She informed that they are aware about the plight of the villagers and visualizing the difficulties faced by the elder peoples and the children. They are facing a lot of problems as there is no work in the village. She requested the District Administration to look into the matter.

**10. Smt. Sita Penthei, Salarapenth**

She informed that the people are financially not stable and do not have adequate food to eat since all the industries in their area are closed down. People have already sold their land since last 5 to 6 years. So, the new proposed plant should come up and provide all facilities to the local peoples.

**11. Smt. Jira Penthei, Salarapenth**

She informed that people have already sold their land and are not financially stable and are not getting food to eat. They are also not getting clean water to drink. So if the industry comes up and operates, the management shall take care of their needs.

**12. Sri Jaya Penthei, Salarapenth**

He informed that the mines and industries in their area have been closed since last 5-6 years and the people are suffering a lot. He wanted the new proposed industry to be set up so that the people will get work and be benefitted.

**13. Sri Kailash Penthei, Salarapenth**

He informed that the mines and industries in their area have been closed since last 5-6 years and the people are suffering a lot. He told that if the plant starts operating the people will get work and their livelihood will improve.

**14. Sri Khageswar Mohanta, Salarapenth**

He informed that since last 10 years he has been staying in Salarapenth area and people have sold their land to the industry and crushers. These units have been closed since long and people are now without any work. He said if the new plant comes up the people will get work and live happily. He also highlighted that the condition of the people in these area is very serious and people have to go without food. He said that the new proposed plant should come up at any cost.

**15. Sri Jagabandhu Penthei, Salarapenth**

He informed that the Company has already acquired their land for the proposed plant and wanted to know that whether the industry will be set up or not. They do not have any work and now the company should provide engagement to them. If they get any pension then they can survive.

**16. Sri Bhagirathi Penthei, Salarapenth**

He informed that the people have gathered here for the public hearing and wants the plant to come up and start operating. If the plant operates people will get work and live happily. The people will get employment in the industry and there will be change in their living status and finally demanded that the industry should come. He welcomed the proposed project.

**17. Sri Satya Penthei, Salarapenth**

He informed that the earlier demands made by the people should be fulfilled by the Company. The old men and women of the village should be given pension and the unemployed people of the village should be given job and employment. They have formed a committee in Salarapenth village and the outsider taking up the job shall take the approval of the committee. He supported the proposed project.

**18. Sri Satyabrata Palei, Salarapenth**

He told that the industry should come up and they should be given employment.

**19. Sri Sarat Penthei, Salarapenth**

He informed that various companies are coming and providing job for a short term period and then asking them to leave without any justified reason and if this occurs with the new plant they will not spare it. He supported the project and asked the industry to come up and also intimated that they should be given permanent employment and the company should not repeat the policy adopted by the earlier units.

**20. Sri Bidu Penthei, Salarapenth**

He welcomed the dais and told that, now people are suffering and facing severe financial crisis to fulfill their daily needs. So he expected that this project will be beneficial in terms of employment. Finally he told in favour of the project and asked the company management to undertake other issue like education, health and road infrastructure etc.

**21. Sri Sabara Naik, Salarapenth**

He informed that, earlier when the mine used to operate and the local people used to work in it and live happily. But after the mines closed people are suffering a lot and depending on selling of wood cut from the forest. So if this new plant will be established, all the local people will be benefitted. He also stressed that the people are facing difficulty in going to a distance place. So the plant management shall provide a vehicle for them. Finally, he told that permission should be granted to the industry.

**22. Sri Hiran Penthei, Salarapenth**

He requested the plant management to fulfill their demands and provide ambulance, electricity and drinking water facility to their village. He also requested the management to provide permanent employment to them. He requested that the company should not terminate their job after short period which will hamper their livelihood as they will not get job at other place. He told the plant should come up and provide job to them. He also requested for a rain water harvesting pond in their village for bathing purpose with special provisions from men and women.

**23. Sri Priyabrata Palei, Salarapenth**

He welcomed the dais and informed that earlier many crushers had been set up which have earlier taken the land of the villagers. Now all these are closed and the people do not have any work nor there is any other means of livelihood. So, he told that if this proposed plant will be set up, then local people will be get employment and will be benefitted and live happily. Finally he told that permission should be given to set up the plant.

**24. Smt. Dhubuli Penthei, Salarapenth**

She told in favour of the project for setting up of the plant.

**25. Sabari Penthei, Salarapenth**

She informed that they have already lost their land due to industrialization and do not have houses. She told that if the plant is to be set up then the company management shall provide job to their children, houses for shelter, drinking water and shall also provide financial assistance of Rs. 5000/- per month to every senior citizen people who cannot work.

**26. Sri Damodar Sahoo, Mahadeijoda**

He expressed his thanks to the company management for setting up the new project in their area so that the people will get engagement and get regular wages and live happily.

**27. Sri Dasaratha Penthei, Salarapenth**

He stated that their father and forefather used to live on agriculture and now they have sold their agriculture land and do not have any source of income and living in a very poor condition. He favored the project and requested the company management to give special attention on employment of local youth and provide all other facilities.

**28. Sri Debadutta Palei, Mahadeijoda**

He informed that if the new proposed plant comes up the people will get permanent employment and there will be development in their area. He welcomed the project.

**29. Sri Bidyadhara Sethy, Danibapur**

He welcomed the dais, people's representatives and the gathering and informed that after so many years a company has come forward to set up a plant in their area and there will be overall development and he is thankful to them. He requested that the demand raised by the earlier speakers shall be fulfilled. He also informed that in their area there is no education, no job or work and people are living in a very poor condition. So if the plant comes up and start operation quickly than the scenario of their area will change and there will be socio-economic development. He finally favored the proposed project.

**30. Sri Gopabandhu Behera, Tikarapada**

He informed that there has been an economic stand-still and the surrounding areas and the industry is required and setting of this new proposed plant is welcomed. He welcomed and requested the management of M/s K. K. Pellets to start the operation quickly and provide the facilities for the people like employment, education, road, health and help the people to remove this economic stand still.

**31. Sri Dusha Munda, Danibapur**

He informed that the people are living in a very bad condition and there is no pond for taking bath, no provision of drinking water, no water shed management and the local people's representatives are not taking action in this regard. He asked the management should take steps for development works in their area and also provide drinking water facility to the village.

**32. Sri Sushanta Sahoo, Mahadeijoda**

He informed that, he is well aware of the peoples need and everybody wants to live happily and wants the proposed industry to come up. He welcomed the project and told that the plant should be established so that the people shall get employment and other works and requested the company management to provide basis facilities like education, health and healthy environment. Finally he asked the gathering to welcome the proposed project.

**33. Sri Nishikanta Khuntia, Madarangajodi**

While expressing his support for the new project proposal, he requested the company management to do some development works in their village and also provide drinking water facility to their village.

At the end of the meeting Smt. Sarilata Prusty, President, Zilla Parishad, Kendujhar welcomed the dais and the public gathered at the meeting. She informed that she has come to this place in support of the people and she also wants that the industry should come up and asked the company management to fulfill certain demands like: to provide a

- (i) NEW SCHOOL,
- (ii) A HOSPITAL,
- (iii) SUPPLY OF DRINKING WATER,
- (iv) EMPLOYMENT AND ENGAGEMENT TO THE VILLAGERS AND UNDERTAKE DEVELOPMENTAL WORKS IN THE SURROUNDING AREAS.

Dr. Sohan Giri, Regional Officer, State Pollution Control Board, Odisha, Keonjhar asked the Project proponent to give their commitments to the people with respect to the demands raised by the public at the public hearing meeting. Hafizur Rahman, CEO, on behalf of M/s. K. K. Pellets Private Limited, committed that all development works of Salarapenth village and its surrounding villages will be taken care of. He informed that, due to their affection and earlier commitment, they have planned to set up the industry in their village Salarapenth. He lastly requested the villagers to cooperate in the venture undertaken by them.


