

**PROCEEDINGS OF THE PUBLIC HEARING MEETING HELD ON 25.08.2018 (AT 2.30 PM) IN MAHISARA GRAM PANCHAYAT OFFICE FOR ENVIRONMENTAL CLEARANCE IN RESPECT OF DANKARI, BARADA AND BARAMANA HILLOCKS (CLUSTER-5) MINE FOR PRODUCTION OF BUILDING STONE / ROAD METAL OVER AN AREA OF 98.42 HA (24 NOS. OF MINING LEASES) LOCATED IN DANKARI, BARADA AND BARAMANA VILLAGES, TEHSIL DHARMASALA IN THE DISTRICT OF JAJPUR, ODISHA**

The public hearing in respect of the Dankari, Barada and Baramana Hillocks (Cluster-5) mine for production of Building Stone/Road Metal over an area of 98.42 Ha (24 nos. of Mining leases) at Dankari, Barada and Baramana Village, Tehsil Dharmasla in Jajpur District was held on scheduled date & time in Mahisara Gram Panchayat Office in the District of Jajpur with reference to EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and amendments made thereafter.

**The Panel consisted of the following members:**

1. Sri Akshaya Kumar Mallick, Additional District Magistrate (Revenue), Jajpur, Odisha
2. Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Odisha, Kalinganagar.

Sri Akshay Kumar Mallick, Additional District Magistrate (Revenue), Jajpur, supervised & presided over the public hearing process and assisted by Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of Dankari, Barada and Baramana Hillocks (Cluster-5) mine for production of Building Stone/Road Metal over an area of 98.42 Ha (24 nos. of Mining lease) at Dankari, Barada and Baramana Village, Tehsil Dharmasla in Jajpur District.





Welcoming the public, Sri A. K. Mallick, Additional District Magistrate (Revenue), Jajpur welcomed the public and explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He reminded public that the Public Hearing meeting is being conducted following the Social distancing and COVID-19 guideline. He requested the public to follow the Social distancing and COVID guidelines during the public hearing process. He asked the Tahasildar, Dharmasala to deliberate people on the mining proposal.

Sri Saroj Kumar Panda, Tahasildar (Dharmasala) & proponent of the project, welcomed the dais and public. Sri S. K. Panda informed that the Administration has taken all necessary steps to conduct the public hearing meeting following the social distancing protocol and COVID-19 guideline of the Government. Sri Panda deliberated the public overall information on the proposed mining leases. He informed that those people who are unable to attend the public hearing meeting due to bad weather can submit their views through representation to the Administration or State Pollution control Board within next 7 days. Sri Panda requested M/s Kalyani Laboratories Private Limited (RQP) to explain brief on mining proposal, Environmental impact of the project and various environmental and CSR activity to be undertaken during the mining project.

On behalf of Tahasildar, Sri Jagabandhu Bisoi, of M/s Kalyani Laboratories Private Limited (RQP) briefed the mining proposal on Dankari, Barada and Baramana Hillocks (Cluster-5) mine for production of Building Stone/Road Metal over an area of 98.42 Ha (24 nos. of Mining leases). He addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, plantation programme and various other peripheral development activities envisaged in the proposed project.

Then Sri Mallick, ADM (Revenue), Jajpur, requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1. **Smt. Sabitri Sahoo, Dankari**  
Welcoming the dais and gathering, she expressed her grievance on conduct of public hearing during the COVID-19 period. Mrs Sahoo informed that she objected the wagon blasting in the stone quarry and stopped the wagon blasting. However, again wagon blasting is being carried out. She complained the administration for not sealing or taking any action against the wagon blasting adopting units. She informed that a case has been filed by her in the Hon'ble High Court which is in sub judice. She also told that minor minerals are getting theft from Dankari hills and requested the authority to prohibit wagon blasting in the Dankari hill area. Finally she concluded her speech with thank to the Administration.
2. **Sri Ganeswar Behera, Dankari**  
Sri Behera informed that he is facing financial issue due to shutdown of mining in Dankari hill. He told that his livelihood depends directly or indirectly on Dankari hill and expressed his support for the mining proposal.
3. **Sri Anant Mallick, Dankari**  
Sri Mallick informed that he is facing financial issue due to shutdown of mining in Dankari hill and expressed his support for the mining proposal.
4. **Sri Rabindra Nath Das, Dankari**  
He told that they are facing unemployment due to shutdown of Dankari Hills and requested the District Administration to give lease permission in Dankari hills for the benefit of the local people.
5. **Sri Gopabandhu Mallick, Dankari**  
Sri Mallick told that He is facing crisis during COVID period and requested the District Administration to give lease permission in Dankari hills so that he will be benefitted from the stone mining project.
6. **Sri Dusashan Behera, Dankari**  
Sri Behera informed that 80% local people are laborers and depend on Dankari Hills for their livelihood. He expressed his support for the stone mining proposal and requested the District Administration to give lease permission in Dankari hills and plant trees in the surrounding areas.
7. **Sri Sankarshan Prusty, Dankari**  
Welcoming the panel and gathering, Sri Prusty informed that 70% people are laborers and they are facing financially due to shut down of Dankari hill. He



requested the District Administration to grant lease as per Government guideline for the benefit of local people.

8. **Sri Gokula Chandra Dash, Dankari**

He informed that local people depend directly/indirectly on Dankari Hill. He raised drinking water issue in the area and demanded drinking water facility, health care facility and environment protection in the area. He finally expressed his support for the stone quarry mining proposal.

9. **Sri Khirod Kumar Mallick, Dankari**

Greeting the dais Sri Mallick told that he is facing financial crisis during the last 3 months as their only source of income i.e. Dankari Hill is closed. He supported the stone quarry mining proposal.

10. **Sri Alekh Prasad Pati, Dankari**

Welcoming the panel and gathering, Sri A. P. Pati expressed his support for grant of lease permission in the Hillocks. However, He complained that no facility has been provided in the local area on school transportation, water, health care etc. Sri Pati finally requested the administration to provide those facilities.

11. **Sri Santosh Kumar Behera, Mahisara**

He greeted the dais & gathering and expressed his support for the mining proposal. He informed that many people in the area have lost their life due to kidney disease and requested the District Administration to provide aqua guard in the villages located within 10km radius from the Hill area. Further, he requested the authority to prohibit wagon blasting and allow manual mining in the quarry area.

12. **Sri Nabaghana Mallick, Dankari**

He supported the mining proposal and told that local people will get employment and local area will be benefited by the stone mining project.

13. **Sri Sanatan Ghadei, Mahisara**


Sri Ghadei expressed his support for the public hearing proposal and demanded peripheral development in the local villages.

14. **Sri Babuli Malik, Dankari**


Welcoming the panel & gathering, he supported the Stone quarry mining project.

15. **Sri Nityananda Mallick, Dankari**

Sri Mallick told that the village people are in financial crisis due to shutdown of Dankari hill. He supported the stone quarry mining proposal.



16. Sri Prabodh Kumar Behera, Dankari  
Sri Behera greeted the dais & public and informed that they depend on the hill for their livelihood and they will be benefitted by grant of leases in the Hills. He requested the administration to provide drinking water facility to local area people.
17. Sri Arun Mallick, Dankari  
He informed that local people are going outside for search of employment and requested the Authority to give permission to stone quarry leases for employment and benefit of local people.
18. Sri Jadumani Samal, Dankari  
He thanked the gathering and supported the public hearing proposal.
19. Sri Gokulananda Sahu, Dankari  
He informed that maximum people of the area are laborers and hoped that 90% of the local people will be benefitted from the stone quarry mining project.
20. Sri Krupasindhu Mallick, Dankari  
Welcoming the panel & gathering, Sri Mallick told that he is not objecting the mining proposal however demanded necessary steps for development of local area public.
21. Sri Ajay Kumar Mallick, Dankari  
He expressed his support for the stone mining project and requested the administration to provide drinking water facility in the local area.
22. Sri Bankabihari Majhi, Dankari  
Welcoming the panel & gathering, Sri Majhi informed that the local area will be benefitted from the Stone quarry mining proposal. He supported the mining proposal.
23. Sri Kuna Behera, Dankari  
He welcomed the dais & gathering and expressed his support for the stone mining proposal.
24. Sri Arta Mallick, Dankari  
He supported the Stone quarry mining proposal.
25. Sri Pratap Malik, Dankari  
He supported the stone mining proposal.



26. Sri Soumya Ranjan Prusty, Dankari  
He supported the stone quarry mining proposal.
27. Sri Kanhu Charan Prusty, Dankari  
Sri Prusty told that they are facing financial issue due to shut down of hills. He demanded medical, aqua guard and electricity facility in the area. Finally he supported the Stone Mining proposal.
28. Sri Suranjan Dash, Dankari  
Welcoming the panel & gathering, Sri Dash told that local people are facing financial issue due to shutdown of Dankari Hill and requested the District Administration to give lease permission in Dankari hills. He supported the mining proposal.
29. Sri Manas Sahani, Dankari  
He supported the mining proposal.
30. Sri Giridhari Mallick, Dankari  
He supported the mining proposal and requested the administration to provide drinking water facility in the area.
31. Sri Natabar Samal, Dankari  
He supported the mining proposal.
32. Sri Dola Mallik, Dankari  
He expressed his supported for the mining proposal.
33. Sri Litu Das, Dankari  
Sri Das supported the stone quarry mining proposal and hoped that they will be benefitted from the mining leases.
34. Sri Narahari Khatua, Digamberpur/  
Sri Khatua informed that he is facing financial issue due to shutdown of mining in Dankari hill and expressed his support for the mining proposal in Dankari hill.
35. Sri Prafulla Samal, Dankari  
He told that the local people are facing financial issue due to shut down of Dankari hill. He expressed his support for the stone quarry mining proposal.
36. Sukanta Dehuri, Dankari  
He expressed his support for the mining in Dankari hill.




37. Sri Chandan Mallik, Dankari
