

**PROCEEDINGS OF THE PUBLIC HEARING MEETING HELD ON 25.10.2021 (AT 11.00 AM) IN RAICHANDA GRAM PANCHAYAT OFFICE FOR ENVIRONMENTAL CLEARANCE IN RESPECT OF RAICHANDA SAND MINE OF M/S ST MINERALS PRIVATE LIMITED ON RIVER BRAHMANI OVER AN AREA OF 8.093 HA LOCATED IN VILLAGE RAICHANDA, TEHSIL DHARMASALA IN THE DISTRICT OF JAJPUR, ODISHA**

The public hearing in respect of the Raichanda sand mine of M/s ST minerals Private Limited on river Brahmani over an area of 8.093 Ha at Village Raichanda, Tehsil Dharmasala in Jajpur District was held on scheduled date & time in Raichanda Gram Panchayat Office in the District of Jajpur with reference to EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and amendments thereof.

**The Panel consisted of the following members:**

1. Sri Akshaya Kumar Mallick, Additional District Magistrate (Revenue), Jajpur, Odisha
2. Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Odisha, Kalinganagar.

Sri Akshay Kumar Mallick, Additional District Magistrate (Revenue), Jajpur, supervised & presided over the public hearing process and assisted by Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of Raichanda sand mine of M/s ST Minerals Private Limited on river Brahmani over an area of 8.093 Ha at Raichanda Village, Tehsil Dharmasla in Jajpur District.

Welcoming the public, Sri A. K. Mallick. Additional District Magistrate (Revenue), Jajpur welcomed the public and explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He reminded public that the Public Hearing

meeting is being conducted following the Social distancing and COVID-19 guideline. He requested the public to follow the Social distancing and COVID guidelines during the public hearing process. He asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

On behalf of the project proponent, Sri Sudhir Kumar Barik, of M/s Kalyani Laboratories Private Limited (RQP) briefed the mining proposal and Environmental impact of Raichanda sand mine during production of sand over an area of 8.093 Ha. He addressed the dais and assembled public and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, afforestation programme and various other peripheral development activities envisaged in the proposed project.

Then Sri Mallick, ADM (Revenue), Jajpur, requested the public to give their views, comments and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

- 1. Sri Jatadhari Sahoo, Sarpanch Raichanda GP**  
Welcoming the dais and gathering, he informed that revenue generated from the sand mining is being utilized for carrying out many development work of the Government and sand is essential for carrying out development works. Sri Sahoo informed that sand is covered with tarpaulin cover during transportation and water sprinkling is being carried out for dust suppression. Finally, he requested plantation activity and local area development work in the area.
- 2. Sri Mayadhar Bhuyan, Talajanga**  
Sri Bhuyan greeted the dais & public and reminded the importance of sand mining for carrying out development works. He expressed his support for the mining proposal.
- 3. Sri Bulu Behera, Raichanda**  
Sri Behera expressed his support for the mining project. He informed that local people will be benefitted from the sand mining and sand will be available easily to the local people.

4. **Sri Sudhanshu Sahoo, Kalanda**

He welcomed the panel and gathering and hoped that sand will be available easily in the local area by operation of the sand mine and pending development work of the Government shall be completed in the area. 
5. **Sri Minja Das, Raichanda**

Ltd. has proposed to have Environmental Assessment for Raichanda Sand Mine on river Brahmani over an area of 8.093 ha. in village Raichanda, Tahsil Dharmasala in the district of Jajpur to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.
