**PROCEEDINGS OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL
IMPACT ASSESSMENT FOR BHAGABANPUR DECORATIVE STONE DEPOSIT OF
SRI SOBHAN KUMAR MAHAPATRA OVER THE MINING LEASE AREA OF 17.547 HA
FOR PRODUCTION CAPACITY OF 6,000 CU.METER/ANNUM AT BHAGABANPUR
VILLAGE, KUKUDAKHANDI TAHASIL OF DISTRICT GANJAM, HELD ON 27.10.2021
AT 11.00 AM AT RAJIV GANDHI SEVA KENDRA BUILDING, LANJIA GRAM
PANCHAYAT (PLOT NO. 507, MOUZA- BHAGABANPUR) OF GANJAM DISTRICT**

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Bhagabanpur Decorative Stone Deposit has proposed to have Environmental Impact Assessment for mining lease area of 17.547 ha for production of capacity of 6000 cu.meter/Annum at Bhagabanpur village, Kukudakhandi Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily “Dharitri” dated 23.09.2021 and an English Daily “The New Indian Express” dated 23.09.2021 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report, Executive Summaries (Odia & English) in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Anantei Gram Panchayat, Banthapalli Gram Panchayat, Lanjia Gram Panchayat and the Block Development Office, Kukudakhandi, in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Addl. District Magistrate, Ganjam, Sri Amiya Kumar Sahoo, O.A.S (S) to kindly preside and supervise in the public hearing.

The Addl. District Magistrate, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked the Sri Sobhan Kumar Mahapatra Project Proponent of Bhagabanpur Decorative Stone Deposit to brief about the project.

Sri Sobhan Kumar Mahapatra, Project Proponent of M/s Bhagabanpur Decorative Stone Deposit has presented the salient features of the proposed project, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the project proponent to reduce the impact while executing the project in Odia language.

The Addl. District Magistrate, Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 110 persons were present in the public hearing meeting, only 103 nos. of persons signed in the attendance sheet out of which 8 persons have participated in oral deliberation. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as Annexure-I and Annexure-II respectively.

The statements recorded are as follows:

1. Sri Santosh Kumar Choudhury, At- Lanjia, Dakhinapur

He addressed the gathering and welcomes this proposal. He has demanded the followings:

- i) Local Development.
- ii) Plantation.
- iii) Maintenance of Roads.
- iv) Assistance to local schools by donating table and chairs and organizing cultural events.
- v) Health Camp.
- vi) Local employment.

2. Sri Kunja Bihari Gouda, At- Balakrushnapur, Dakhinapur

He stated that due to mining locality will be developed and Government will also get revenue. He has demanded for local employment in priority, water sprinkling over roads and financial assistance to schools and colleges.

3. Sri Binod Bihari Sethi, At- Anantei, Banthapalli

He stated that the lessee has already mentioned about local employment & other developmental activities to be undertaken by them. He believes that local villagers from Lanjia and Bhagabanpur will be engaged in this mine.

4. Sri Hrusikesh Dakua, At- Anantei, Banthapalli


He expressed that due to operation of this mine local people will get employment opportunity.


5. Sri Kamaraju Gouda, At- Lanjia, Dakhinapur

He addressed the gathering and stated that the mine owner should fulfill the assurance as committed, take steps to control pollution and assist the cultural programmes.

6. Sri Jogendra Gouda, At- Lanjia, Dakhinapur

He stated that the mine owners should take steps to fulfill the commitments made in the public hearing.

7. Sri Gobinda Chandra Gouda, At- Balakrushnapur, Dakhinapur

He addressed the gathering and stated that mines owner should take steps to fulfill the commitments and abide by the Government guidelines. Local employment in all level shall be given to inhabitants of Anantei and Lanjia G.P. Mines are operational in that locality since last 30 years and they have experienced development due to this.

8. Sri Babula Mallik, At- Bhagabanpur, Dakhinapur

He stated that by operation of this mine local public will be benefited and they will also get employment opportunity. He has requested to fulfill the commitments made by project proponent.

Further the Addl. District Magistrate, Ganjam and Regional Officer, State Pollution Control Board, Berhampur also discussed on issues raised by the public and requested to the project proponent of M/s Bhagabanpur Decorative Stone Deposit to address the issues raised by the public. Sri Mahapatra, project proponent of this mine addressed the apprehensions raised by the public.

Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by Sri Amiya Kumar Sahoo, O.A.S (S), Addl. District Magistrate, Ganjam with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.

The statement of issues and concerns of public with the comments of the representative of the project proponent, prepared in Odia and English Language are annexed as **Annexure-III** and **Annexure-IV** separately.

The public hearing was ended with vote of thanks by the chair.



CAD-1256: It is brought to the notice of all concerned that Sri Sobhan Kumar Mahapatra has proposed to have Environmental Assessment for Bhagabanpur Decorative Stone Deposit for production capacity of 6000 Cum/Annum over an area of 17.547 Ha. in village Bhagabanpur under Kukudakhandi tehsil of Ganjam district to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site / sites of displacement / sites likely to be affected.
