

PROCEEDINGS OF THE PUBLIC HEARING MEETING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT OF SILPAPURI SAND BED MINES PROPOSED BY TAHASILDAR, CUTTACK SADAR ON RIVER KATHAJODI OVER AN AREA OF 5.06 HECTARE OR 12.50 ACRES AT VILLAGE SILPAPURI UNDER CUTTACK SADAR TAHASIL OF CUTTACK DISTRICT

The Public Hearing meeting in respect of Environmental Impact Assessment of Silpapuri Sand Bed Mines proposed by Tahasildar, Cuttack Sadar on River Kathajodi over an area of 5.06 hectare or 12.50 acres at village Silpapuri under Cuttack Sadar Tahasil of Cuttack district was held on 30.10.2021 at Community Centre, Odisha Government Press Colony, Nuapada, Cuttack Sadar Tahasil in Cuttack district, Odisha at 11.30 am with reference to:

1. EIA Notification S. O. 1533(E) dated 14.09.2006.
2. Interim Operational Guidelines.

At the outset, welcoming the members participated in the meeting presided over by the Additional District Magistrate, Cuttack, the representatives of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by the Tahasildar, Cuttack Sadar.

Welcoming the public, Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Odisha, Cuttack, explained the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. She asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

Sri Sambit Kumar Garnayak, Tahasildar, Cuttack Sadar, (project proponent), addressed the committee members and the assembled public and informed that they have engaged Environment Consultant i.e. M/s. Kalyani Laboratories Pvt. Ltd., Bhubaneswar for this project and requested them to make a presentation about the project. Sri Mrutyunjay Das, representative of M/s. Kalyani Laboratories Pvt. Ltd addressed the panel members and

the assembled public. He made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other CSR activities envisaged in the proposed project.

Then Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Cuttack requested the public to give their views, comments, objections and opinions on the proposed project.

**The following speakers gave their views on the above said project, which are given as follows:**

**1. Sri Manoj Basantray, Nuapada Labour Colony, Cuttack :**

He welcomed the dignitaries and public present in the meeting. He said there are twelve Nos. sand sairat sources under cuttack Sadar and Silpapur sand quarry is one of them. He stated that the auction of these sand quarries have been completed two years before and highest bidders have spent their money for the sand quarry but its operation got delayed due to the COVID pandemic situation. He said that though government sand quarry were not operated during last two years but illegal sand mining was done by some people taking the advantages of COVID situation and they are selling the sand at higher price. He mentioned that common people during construction activity are facing a lot of difficulties due to the higher price of sand when there was no income of people during COVID time. He said that if the sand quarry would have operated than they could have get sand at lower price. He said that though Tahasildar is doing raid on illegal sand mining and imposing penalty on them. But the penalty is not enough for them and the people doing illegal mining are not caring it. He further stated that the operation of the sand quarry will not much pollute the environment. But if more plantations will be done by the Government along river side and along the road more oxygen will available and it will be benefited for environment. He said that operation of sand quarry will not create sound pollution or environmental pollution. He requested the authority to allow the sand bed mine to operate so that common people will get benefit and the illegal mining should be stopped.

**2. Sri Bibhuti Bhusan Swain, Balisahi, Nuapada, Cuttack :**

He welcomed the dignitaries and public present in the meeting. He said that he is a construction contractor and construct building after obtaining tender. He told that whatever house construction agreement he had signed two years before it is difficult for him to complete it as he is unable to get sand from Nuapada and its nearby sand

ghat of Kathajodi. So he is bringing sand from distance location and the cost of sand is increasing. Further he informed that due to non availability of sand in time construction work is getting slow and production cost is increasing. He said that due to non operation of sand ghat in this location they get affected financially and unable to complete work in time. He requested to the authority if the Silpapuri sand quarry will operate they can operate their business smoothly.

**3. Sri Siba Shankar Panda, Nuapada, Cuttack :**

He welcomed the government officials. He said that this sand ghat should operate earlier. As the sand ghat was not in operation people have faced problem during construction activity. He said that as soon as the sand ghat will operate all people will get benefit and their area will be developed. He requested to provide approval as soon as possible for operation of the sand ghat.

**4. Sri Saroj Kumar Das, Nuapada, Cuttack :**

He welcomed the dignitaries and public present in the meeting. He said that due to non operation of the sand ghat the people associated with construction activity like labourers, mason and others have faced many problems. Further he stated that as the sand ghat is not in operation since last two years, so if the authority will allow this sand ghat to operate they will be obliged.

**5. Sri Ranjit Barik, Nuapada Market, Cuttack :**

He welcomed the dignitaries and public present in the meeting. He said that due to non operation of the sand ghat since last two years the income source of many small and major businessman have been affected. The income source of labourers and masons has been affected as their income source depends on availability of sand. So he requested to the government if the sand ghat is allowed to operate than the local people will be obliged and businessman depends on sand business will be benefited.

At the outset total five nos. of people had registered their names to express their views, comments etc. and deliberated their views accordingly.

After all the speakers completed their respective opinion and suggestion, the Regional Officer, Cuttack asked the project proponent to give relevant reply, if any to the issues raised. Sri Sambit Kumar Garnayak, Tahasildar, Cuttack Sadar (project proponent) committed that he will take steps for plantation in consultation with Forest Department on vacant space available in the nearby area. Further he stated to take

necessary pollution control measures and comply with the conditions given in the Environmental Management Plan. He stated that the lessee will operate the sand ghat without damaging the environment.

Then Sri Pratap Chandra Beura, Sub collector, Cuttack Sadar also clarified some of questions raised in the programme. He opined that operation of the sand ghat is required for development activity but at the same time environment is also important. As per the guidelines of Ministry of Environment Forest and Climate Change guidelines the public hearing is conducted. He said that the guidelines of SEIAA should be followed by the lessee and he should be careful that there shall not be any damage of river and its embankment. The lessee should take measures like water sprinkling on road and cleaning of road for control of pollution and the work should not be limited on pen and paper.

Finally the Regional Officer requested the Additional District Magistrate, Cuttack to give his views on the public hearing meeting.

Then the President of Public Hearing meeting, Sri Purna Chanda Mishra, Additional District Magistrate, Cuttack welcomed all the government officers and public presented in the meeting. He informed that previously sand ghat was allowed to operate yearly basis and there was no specific regulation. However in the new guidelines of the government has given more emphasis on Environment and accordingly the sand ghats are required to obtain Environmental Clearance and Consent to operate. He said that as observed all people presents here wanted that the Silpapauri sand ghat to be operated so the project proponent should carry out with the promises as mentioned in their project report.

Finally, the Regional Officer, Cuttack ended the meeting with thanks to the Chair.

It is brought to the notice of all concerned that **Tahsildar, Sadar, Cuttack** has proposed to have **Environmental Assessment for Silpapuri Sand Bed mines on River Kathajodi over ML area of 5.06 Ha. at village Silpapuri, tehsil Sadar of Cuttack district** to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site / sites of displacement / sites likely to be affected.

For the above purpose, a person will only mean:

- A. Any person who is likely to be affected by the grant of Environmental Clearance.
- B. Any person who owns his control over the project with respect to which an application has been submitted for environmental clearance.
- C. Any association of persons whether incorporated or likely to be affected by the project and / or functioning in the field of environment.
- D. Any local authority within any part of whose local limits is within the neighborhood, wherein the project is proposed to be located.

Persons as above who desire to submit their views, comments, objections etc. relevant to the project, may do so in writing within 30 days from the date of publication of this notice addressing the same to the Member Secretary, State Pollution Control Board, Odisha through Registered Post. Besides this, persons interested to submit their views relevant to the proposed mining project in writing or orally may also do so during the public hearing to be conducted on 30.10.2021 at 11.30 A.M. at **Community Center, Odisha Govt. Press Colony, Nuapada, Cuttack**.
