

Sealed Quotations/Tenders are invited from the interested reputed Travel Agencies/Tour Operators or private individuals for providing 05 nos. of Mahindra Bolero/ TATA Indigo AC Diesel driven vehicles having sitting capacity not more than five including driver with minimum average mileage of 15 Kms for AC TATA Indigo and 10 kms. for AC Mahindra Bolero per litre of diesel, which shall conform to the Terms and Conditions (**Annexure - I**) for official use in the State Pollution Control Board, Odisha on monthly rent basis:

- 1) The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Member Secretary, State Pollution Control Board, Odisha, Bhubaneswar and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) **The financial bid indicating monthly hiring charges, (excluding fuel and lubricants) within the fixed rate of Government and charges towards outstation tours shall be submitted separately in sealed cover as per Annexure -II super-scribing financial bid for hiring vehicles on the top of the envelop.**
