Sealed Quotations are invited in plain paper from interested reputed Travel Agencies/ Tour Operators of private individuals for providing vehicles on hiring basis who conform to the following Terms and Conditions for official use in the State Pollution Control Board, Odisha, A/118, Nilakantha Nagar, Unit-VIII, Bhubaneswar-751012:

- 1) The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle. The Board hiring vehicles shall not be responsible for any damage / loss caused to hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The bidder shall be responsible for all such litigation.
- 2) The consumption of HSD/Lubricant will be borne by the Agency.
- 3) Only taxi permitted vehicle will be provided by the Agency.
- 4) GST would be reimbursed over and above the hire charges and TDS will be applicable to the bill.
- 5) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 6) The Driver should be well behaved, gentle and obedient in nature.
- 7) In case of the vehicle do not report in time, the authority will be at liberty to reject the agreement and may engage vehicles from other source.
- 8) If the services are found to be unsatisfactory, the authority shall give one month notice and terminate the agreement.

- 9) The rates for local run and long run with terms & conditions for all models namely, TATA Indica, Maruti Van, TATA Sumo, Toyota Qualis / Innova / Travera / TATA Safari / Mahindra Scorpio / Bolero/ TATA Indigo (both AC & Non-AC) should be quoted .
- 10) The Agencies should provide an user list indicating the names of Govt. Deptt. / Undertakings and other reputed bodies who are using their vehicles and satisfied with their services.
- 11) A sum of Rs.5000/- (Rupees Five Thousand) only shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Member Secretary, State Pollution Control Board, Odisha, Bhubaneswar and submitted along with the quotation as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 12) If the bidder violates any of the terms of contract, the authority will forfeit the entire amount of security deposited.
- 13) The Quotation completed in all respect should reach the undersigned on or before **25-09-2019** by **3.00 PM** and shall be opened on the same day at **4.00 PM** in presence of the bidders or their authorized representatives. The tender documents will open in the office chamber of Member Secretary, State Pollution Control Board Odisha.
- 14) The authority reserves the right to cancel all or any of the quotations without assigning any reason thereof.


