In inviting a reference to above, it is to inform the following:

- 1) The Board has intimated vide letter under reference to include consent to establish and consent to operate in the schedule of essential public services under ORTPS Act, 2012 and accordingly list of designated officers, Appellate Authorities and Revisional Authorities w.r.t. Consent to establish and Consent to operate has been sent for making the amendments in ORTPS Act. 2012. Copy of the same is enclosed as **Annexure – A**.
- 2) The Industries Department, Govt. of Odisha has communicated new “Business Reforms Action Plan” of Department of Industrial Policy and Promotion (DIPP), Govt. of India for the year 2017 under “Ease of Doing Business in the State” wherein it is mandated to define clear timelines mandated through the Public Service Delivery Guarantee Act (or equivalent) legislation for approval of complete application for authorization under Hazardous & Other Wastes (Management and Transboundary Movement) Rules, 2016 and authorization under Bio-medical Waste Management Rules, 2016.
