KIND ATTENTION TO ALL MUNICIPAL CORPORATIONS/ MUNICIPALITIES/NACS

Whereas Municipal Solid Waste (Management and Handling) Rules, 2000 has been notified by the Ministry of Environment & Forests, Govt. of India under Environment (Protection) Act, 1986.

And whereas major responsibility has been given to Urban Local Bodies for effective implementation of the statutory provisions of the Rules.

And whereas, time limit to identify suitable landfill site/sites in accordance with Schedule-III of the Rules is over since 31.12.2002. Further, the time limit for setting up waste processing/disposal facility and to seek authorization from the State Pollution Control Board, Odisha for the same is over since 31.12.2003.

And whereas despite repeated correspondences to all concerned, notice published in the news papers, and discussion on this issue at several State and District level interaction meetings as well as workshops, training programmes organized by the State Pollution Control Board, Odisha, the response is not satisfactory. Most of the Urban Local Bodies are disposing the municipal solid waste at different unauthorized site/sites in violation to the provisions of the Rules.

The State Pollution Control Board, Odisha therefore directs all of the following defaulting Urban Local Bodies, through this notice once again to take action for identification of suitable landfill site/sites as per the criteria specified in the Schedule-III of the Rules and apply in prescribed form (Form-I) giving all correct and required information/documents for obtaining authorization from the State Pollution Control Board, Odisha forthwith to avoid initiation of legal action as per Section-15 of Environment (Protection) Act, 1986.
