Dated, Bhubaneswar, the 30-9-14

No.Env-I-72/2013 18164 /F&E, In exercise of powers conferred by Section-19 ,Clause(I) and (3) (a) of Water (Prevention & Control of Pollution) Act ,1974 and Section 19 Clause (I) and (2)(a) of Air (Prevention and Control of Pollution) Act, 1981, State Government in consultation with State Pollution Control Board, have decided that since the air and water pollution potential of I.T. / ITES industries are marginal, premises of all I.T. /ITES Industries shall be kept out of purview of Water (PCP) Act and Air (PCP) Act and hence shall be exempted from consent administration of the SPCB in order to encourage the growth of the I.T./ ITES Sectors in the State.

SEEEN

They will, however, be required to self-regulate the implementation of water, air and environmental pollution control measures as stipulated in the Water (Prevention and Control of Pollution) Act, 1974, Air (Prevention and Control of Pollution Act, 1981 and Environmental (Protection) Act, 1986 and submit a certificate regarding the compliance of the above laws, to the State Pollution Control Board every year.

This issues in partial modification of Notification No. 11480,dated 18.7.2002 and in supersession of Resolution No.1751, dated 28th January, 2004.




