## OFFICE MEMORANDUM

### **EMPANELLEMENT OF THIRD PARTY ENVIRONMENTAL AUDITERS FOR ISSUE OF “NO INCREASE IN POLLUTION LOAD” CERTIFICATE TO THE PROJECT PROPONENT FOR CHANGES IN PLANT CONFIGURATION & PRODUCT MIX FOR THE PROJECT.**

Whereas the MoEF&CC, Govt. of India, vide an amendment in the EIA notification vide S.O. 3518(E) dated 23.11.2016 has exempted environmental clearance for the projects who change their plant configuration and product mix after they obtained environmental clearance, provided the change in product mix as well as plant configuration does not result in net increase in pollution load. For this purpose, State Pollution Control Board has to certify that there is no net increase in pollution load.

And whereas as per the procedure laid down by MoEF&CC, Govt. of India, in the above said Notification, the State Pollution Control Board shall issue such certificate on the recommendation of the Technical Committee. The Technical Committee shall evaluate the case on the basis of a certificate of no increase in the pollution load from the Environmental Auditors and reputed institutions to be empanelled by State Pollution Control Board. The applicant alongwith Environmental Auditors shall also make presentation before the Technical Committee.


And whereas CPCB, New Delhi has published guidelines-cum-standard operating procedure for engaging Third Party Assessors (TPA) and Institution identified by CPCB in June, 2015. In the said guidelines, the CPCB has provided list of Government controlled institution / organisation which in the opinion of Central Pollution Control Board are eligible for engagement as Third Party Assessors (TPA).

And whereas, it was decided that the State Pollution Control Board in the first phase, may empanel the institution of Odisha as appeared in the guidelines of Central Pollution Control Board as Third Party Auditor for the State of Odisha.

Now, therefore, in pursuance to MoEF&CC, Govt. of India Notification SO.3518(E) dt.23.11.2016, the following institutions of Odisha are hereby empanelled by State Pollution Control Board, Odisha as 3<sup>rd</sup> party Environmental Auditor for issue of "No increase in Pollution Load" certificate to the project proponent for changes in the plant configuration and product mix for the project based on proper technical scrutiny and evaluation of the proposal..
