### NOTICE

### KIND ATTENTION TO ALL MUNICIPAL CORPORATIONS/MUNICIPALITIES/NACs

**Whereas**, Ministry of Environment, Forest & Climate Change, Govt. of India has notified **Solid Waste Management Rules, 2016** on 08.04.2016 in supersession of the Municipal Solid Waste (Management and Handling) Rules, 2000 under Environment (Protection) Act, 1986.

**And whereas**, major responsibility has been given to urban local bodies for effective implementation of the statutory provisions of the Rules.

**And whereas**, as per Rule-24 (2) of the Solid Waste Management Rules, 2016 the responsibility of the ULBs is to submit annual report in Form-IV to the State Pollution Control Board on or before the 30<sup>th</sup> of June every year.

**And whereas**, Central Pollution Control Board in the review meeting with SPCBs/PCCs held on 18<sup>th</sup> February 2017 at Delhi informed all State Pollution Control Boards the hazards of collapse of Ghazipur landfill site, Delhi and stressed on the need to ensure structural/slope stability of existing landfill sites and adoption of preventive measures like Bio-remediation, Bio-mining and utilization of segregated inerts in road construction/earth filling to safeguard the environment against such untoward incidents.

**Now therefore**, the State Pollution Control Board, Odisha directs all urban local bodies, through this notice to take action for compliance of the provisions of the Rules, submission of annual report in time to State Pollution Control Board and preparation of detail and time bound action plan for management of solid wastes. Further, all Urban Local Bodies are requested through this notice for verification of the structural/slope stability of the existing landfill sites and adoption of preventive measures as suggested by CPCB to safeguard the environment against untoward incidents such as the one at Ghazipur, Delhi.
