
NOTICE

ATTENTION – All Occupiers of the Non-bedded Health Care Facilities including Research Organization and the Laboratories in Universities generating biomedical waste

This is brought to the notice of **all occupiers of the Non-bedded Health Care Facilities including Research Organization and the Laboratories in Universities generating biomedical waste** that Ministry of Environment, Forest & Climate Change, Govt. of India in supersession of Biomedical Waste (Management and Handling) Rules, 1998 has notified Biomedical Waste Management Rules, 2016 under Environment (Protection) Act, 1986 on 28th March, 2016 and as amended thereafter. As per the provisions of the Rules, the occupiers of all non-bedded health care facilities shall obtain one time authorization.

As per the direction of Central Pollution Control Board, Delhi **all the non-bedded occupiers including Research Organization and the Laboratories in Universities generating biomedical waste** shall dispose their waste only through a Common Biomedical Waste Treatment Facility located in their respective areas. Occupiers of all non-bedded health care facilities are requested to apply for authorization online through odocmms.nic.in/ospcboard.org.

It may be noted that the occupier shall be liable for action under Section-5 and Section-15 of the Environment (Protection) Act, 1986 in case of any violation.




