NOTICE

Kind Attention : E-Waste Generators and Producers/Manufacturer of Electronic and Electrical Equipment (EEE)

This is brought to the notice of all concerned that Ministry of Environment, Forest & Climate Change, Govt. of India has notified the E-Waste Management Rules, 2016 and E-Waste Management Amendment Rules 2018 under Environmental (Protection) Act, 1986 in supersession of the E-Waste (Management & Handling) Rules, 2011. The Rules shall apply to every manufacturer, producer, consumer, bulk consumer, dealers, e-retailer, refurbisher, dismantler and recycler involved in manufacture, sale, transfer, purchase, collection, storage and processing of E-Waste of electrical and electronic equipment including their components, consumables, parts and spares.

The copy of the E-Waste Management Rules, 2016 and Amendment Rules, 2018 are available in Boards' Website: www.ospcboard.org and website of MoEF&CC: www.envfor.nic.in. As per the provisions of the Rules, the producers of electrical and electronic equipment will collect the 'end-of-life' electronic equipment and channelize them to authorized dismantlers/recyclers under Extended Producer Responsibility (EPR). The producers will collect E-Waste by implementing take back system, E-Waste exchange or through Producer Responsibility Organization (PRO) engaged by them. The producers are to implement Deposit Refund Scheme (DRS) for effective collection of E-Waste through their dealers.

The bulk consumers of electronic equipment such as Central Government, State Government Departments, Public Sector Undertakings, Banks, Educational institutions, Multinational Organizations, International Agencies, Partnerships and Public or Private Companies that are registered under the Factories Act, 1948 (63 of 1948) and the Companies Act, 2013 (18 of 2013) and health care facilities which have turnover of more than one crore or have more than twenty employees shall ensure that the E-Waste generated by them is channelized through Dealer of authorized Producer or Dismantler or Recycler or through the designated take back Service Provider. Bulk consumers shall maintain records of E-Waste generation and submit Annual Return in Form-III to the State Pollution Control Board on or before the 30th June following the financial year.
