<u>ATTENTION – All Occupier of Health Care Facilities under Biomedical Waste</u> Management Rules, 2016

This is brought to the notice of all occupiers of Health Care Facilities (HCFs) operating in Sundargarh, Sambalpur, Deogarh, Jharsuguda districts that a Common Biomedical Waste Treatment & Disposal Facility (CBWTDF) namely M/s Mediaid Marketina Services has been established and is in operation at Amasarnga, Majhapada in Sundargarh District with valid Authorization and consent to operate from the Board. This facility has come up in substitution of the CBWTF operating at RGH, Campus, Rourkela. The CBWTF at RGH is closed now after the new facility came into operation. All the Health care facilities those were availing the services of CBWTF at RGH Campus, Rourkela (operated by Mediaid Marketing Services) are requested to execute agreement with M/s Mediaid Marketing Services to continue with transport, treatment and disposal of Biomedical waste at its new facility at Amasarnga. As per Section-3 of Biomedical Waste Management Rules, 2016 no occupier shall establish on-site treatment and disposal facility, if service of an authorized common bio-medical waste treatment and disposal facility (CBWTF) is available within a radius of seventy-five kilometer. Disposal of wastes in deep burial pits as specified in Schedule-I of the rule shall be permitted only in rural and remote areas where there is no access to the authorized Common Biomedical Waste Treatment & Disposal Facilities.
